

# Making the Best Impression as a Law Clerk or New Associate

After having hired, trained and supervised a number of law clerks and associate attorneys during my time in law firm and in-house practice, I thought it would be helpful to provide a short list of reminders and suggestions that may assist our students and recent graduates to make the best impression as a law clerk or new associate attorney.

With these tips, and your hard work, you will be on the right track to impress any potential employer.

#### **Develop Good Work Habits**

- 1. Hours: Be early! Call if you are running late or will be out.
- 2. Prioritize tasks to complete them on time and don't limit yourself to just one project at a time—show that you can multitask!
- 3. Treat everyone with respect! Stay out of office politics. Avoid gos siping about anyone.
- 4. Communicate. Make sure all attorneys with whom you are working know what you are doing.
- 5. Keep a log of the work you are doing. This will help with time keeping (and later for your review and resume).
- 6. Bring a pen and paper everywhere! Assignments may be given at any moment. Time is precious.
- 7. There is no such thing as a "rough draft". Always turn in your best work. Never submit a draft.
- 8. Always clarify and confirm the nature of the assignment before you leave the office by summarizing the assignment back to the su pervising attorney: "So what you want is a client memo summriz ing their rights of reinstatement under California law and you need this by Monday. Is this correct?"
- 9. Resolve Questions ASAP. If you're still confused, ask follow up questions either in person or by email to ensure you give the attor ney what she needs.
- 10. Be prepared. The only thing worse than walking into an attorney's office unprepared is doing so in the company of someone who is prepared.

#### Work Assignments: Questions to ASK upon receiving a new assignment

- 1. When is the due date and do you want status updates? Attorneys often don't have a deadline in mind when they ask you to under take a project. However, when they want the results of your project, they will want them immediately. To avoid being unprepared, press the attorney for a deadline and then deliver your work early.
- 2. Do you want a written or verbal response? As to research, sometimes attorneys want might want a formal memo, but often they just want a quick email or verbal briefing on the issue.
- 3. Are there any reference materials that you think I should look at first? Code section? Practice guide?
- Who will be the audience for this document? Supervising attorney the client, the court, etc.? The intended audience will set the tone and level of complexity for the document. Are there procedural rules or standards that affect the approach I 5. should take? For example, a complaint and demurrer address allegations, whereas a motion for summary judgment also requires admissible evidence in support of allegations. What is the jurisdiction for this case or matter? Don't be that guy 6. who prepared a well-reasoned memo analyzing California deficiency statutes for a matter that involved a property located in Arizona! Not helpful! Do you have a template or sample that I should follow? Different 7. firms will have different policies and procedures in how they handle certain memos, drafts, letters, etc. It's important that you conform your work product as soon as possible. Is there a page length or limit? Many motions have page limits, 8. and some attorneys prefer even shorter written work. Ask to save yourself time. Where would I find the complete file? What materials should I 9. review for background/context (e.g., the case file, prior correspon dence, etc.) How long should I spend on this project? This question saves you time 10. from spending twenty hours researching a particular issue if the assigning attorney believes it should only be a two hour assignment.

## **Book Review- My Beloved World**

Raised in a housing project in the Bronx with an alcoholic father who died while she was young, Justice Sonia Sotomayor


experienced loss and struggle early on. She was diagnosed with juvenile diabetes at seven and learned to give herself her own insulin shots. She dealt with drug addiction and AIDS in her family later on. She survived the demands of law school and a failed marriage with grace and candor.

The story of Sotomayor's rise from a broken family in a Bronx housing project, through the Ivy-covered walls of Princeton and Yale, to the highest court in the country is not just a story of individual success and aspiration. Sotomayor weaves together a story of courage, resource-fulness and aspiration inspiring to any reader, but especially touching to those who have struggled to create something for themselves out of nothing.

Many law students may feel overwhelmed by their course load and feel unable to include additional readings in their schedule. I would assuage those concerns by telling you Sotomayor's memoir reads like a conversation with a wise friend hoping to impart wisdom through her own narrative of struggle and success.

Sotomayor struggled to develop self-confidence and recognize the strength and insights she brought to the table. She came from humble beginnings. Yet, she allowed her struggles not to define who she could become but to define how she would become who she knew she was always meant to be.

During her time in Princeton, Sotomayor felt out of place and behind many of her peers who came from more affluent backgrounds with greater resources and expectations of success. Sotomayor did not let this hold her back, but embraced her upbringing for the experiences and insights it allowed her to developed. She did not "fail to appreciate that [she] had experiences of [her] own to prize or that [she had] seen some aspect of life of which [her] classmates were sometimes naively unaware."



While she did not have much growing up, her mother prioritized education and instilled in Sotomayor early on the belief that you can achieve anything you set your mind to. As Sotomayor struggled through the challenges of academia, she often felt there was "something else [she] was supposed to know." As if she had missed out on many opportunities growing up which now set her back as an adult. Rather than accept the status and conditions she was born in to, Sotomayor chose to challenge the limits imposed on her by class and cultural background. Though she feared these gaps in her knowledge might be indicative of a lack of aptitude, she recognized that for many of her peers "the agenda for self-cultivation that had been set for [them] by their teachers and parents" was something she would have to develop and create for herself. To her, this meant a commitment to being a life-long learner. This meant challenging herself to use her background and lived experiences as a catalyst to acquire the knowledge and

skills that for others may seem like a birthright. From her memoir, you understand that her background experiences and adversity are as much her source of strength as they are her

5. **Do something**. I failed miserably in this the first semester. I ended up looking as white as a polar bear from lack of sun exposure and left in the worst physical shape of my life. Take an hour a day and do something that is not school related. Gym, beach, run, read an unrelated to school book (you are a better person than I if you can still read after all the class readings), hang out with friends – it does not matter, just do something not related to school each and every day. You may not get a chance every day realistically, but actually plan for it and incorporate it into your daily to-do list, and ultimately you will end up feeling much better about yourself.

I hope the tips help you cope with the stress of both getting our first set of grades back but also from the generally stressful experience of law school. Find a balance, find a rhythm, and find what works for you without having a heart attack during school. struggles in life.

Though she is coy about her experiences at Princeton and Yale Law School and how they may have shaped her views of the legal system and politics, she is frank about discussing the role affirmative action played in propelling her from the free health clinics where she was treated for juvenile diabetes in the Bronx to the bench at 1 First Street NE, Washington, DC 20543.

She recounts regular letters in the Princeton student newspaper where complaints appeared asserting students like Sotomayor were taking the place of worthier, more qualified students. Sotomayor is candid and readily offers praise and thanks to those who shaped her experiences. Indeed, Sotomayor underscores that it does take a village. Sotomayor discusses intimate details of her blood family, the extended family she created for herself and mentors who offered her help and advice.

Sotomayor recognizes she was shaped a life of racism, dearth, family tragedy and self-doubt. Yet by the end of her memoir, you recognize a woman who is an epitome of the American Dream. She is unapologetic about her life experiences or the opportunities that were afforded to her because of them.

This book should serve as a reminder that we are more than where we come from and can accomplish much more when we work together and allow others into our lives and hearts. Last semester when the monotony of law school had me down, I could turn to the pages of

#### **Pizza Port:**

You can taste Pizza Port's own beers brewed at their different locations as well as beers from their guest beer tap list. #### O'Brien's Pub: 4646 Convoy Street

## Nicolai Abramson: A December 2013 Graduate and Local Business Owner

You might recognize Nicolai Abramson, a recent CWSL alumni, who's now deep in the trenches of the library preparing for the February Bar exam. Nicolai was previously featured in the Commentary way back in the glory days of his 2L year. Nicolai is an active home brewer and occasional beer drinker. Since that article came out, I embarked on a journey rebuildng my brewery from scratch, using stainless steel parts I found at the scrap yard. Frankenstina (the name of his brewery) is taller, bigger and louder than I am. Her parts ended their previous lives as forgotten scrap metal wasting away in scrap yards" said Nicolai.

I recently spent an evening meeting Nicolai at something else he recently created, a vape shop called Electromist. It's after hours and the first thing I notice outside his shop is the video of what I think is smoke being projected on the window. I'm

perplexed, because Electromist anything but a smoke shop. "It's not smoke. Its vapor" he says. "That's our slogan- No Smoking, Just Vape!"

Nicolai has me sit and brings me an e-juice menu and a Mexican Coke. He says, "Try anything you want. I let customers try our e-juices to see what which ones they like. None of my samples have nico (tine) in them." The menu has over 40 different e-juices to sample; I feel like I'm at the adult version of Baskin Robbins.

Nicolai says that his inspiration for Electromist came when he learned that new technology exists that serves as a better alternative to a harmful habit that has been killing people for hundreds of years. Americans have been smoking tobacco since before this country was founded. Tobacco was the basis of the early economies of the many of the original southern colonies before the Revolutionary War. Our families in the old world smoked it long before the colonies even existed.

Unfortunately, despite all of the technological advances, many people that still smoke today. Nicolai continues, "But at the same time, this is 2014. California is the place to be in the modern era; we love our electronic devises: Phones, tablets, laptops, etc. Tesla is revolutionizing the car market by replacing gas combustion engines with electric ones. I'm selling the same principle with respect smoking. I guess you could call me Nicolai Tesla."

"Most smokers crave nicotine, a byproduct that comes from combusting (burning) tobacco. But tobacco combustion also releases countless other unhealthy toxins and carcinogens. Nicolai says his background in law school, specifically at California Western has helped him tremendously in the creation of his business. "Law students have a lot of potential because they're smart and they work hard, or else they wouldn't be here, doing what they do. Use those abilities and build something bigger than yourself.
